

OCTA Pedestrian Safety Quiz – Official Rules

By participating in this promotion you, agree to the **Official Rules**

Eligibility: To enter, you must be at least 18 years of age, or have a parent or legal guardian's permission to enter. OCTA employees, sponsors, vendors, agents and their immediate family members are not eligible.

Timing: The Sweepstakes begins at midnight on April 27, 2014 and ends on May 31, 2014 at 11:59 p.m. All winners will be selected and announced by June 12, 2014.

How to Enter: During the promotional period, go to www.BeRoadSmart.net and complete the safety quiz. Upon submission of your registration form you will receive one (1) entry into the Sweepstakes. **Limit:** One entry per person.

Drawings: OCTA will randomly select the potential winners from all eligible Sweepstakes entries received by the time of the drawings. Winners (3 total) will be randomly selected and announced at the end of the promotion. Additionally, one grand prize winner will be randomly selected at the conclusion of the promotion. OCTA staff will notify the potential winners of their prize via contact information provided to OCTA by the Sweepstakes participants, i.e., email address, telephone number, and/or postal address. A minimum of three attempts will be made to contact the winners using the contact information provided. If the designated winner does not claim the prize within thirty (30) days of the date of the first attempt of contact, that winner shall forfeit receipt of the prize.

Prizes: Limit of one prize package per participant. Grand prize: (1) iPad. Second prize: (2) 30 day OCTA bus passes

Prizes must be accepted as awarded, may not be substituted, and have no cash value. Exchanges or replacements will not be made if a prize is lost, stolen, or damaged.
